4. Consideration and approval of the holidays during vacation periods for all non-teaching Institute staff members.

The board was apprised that other IITs have a practice of granting a five-day holiday to all non-teaching staff during the notified vacation in a calendar year. In line with the same, it was proposed that five days of holiday be granted to all non-teaching staff of the institute during vacation, subject to the conditions mentioned. However, according to the comments received from MoE, there are no guidelines for vacation for non-teaching staff, which is purely administrative staff, and the proposal was not supported. However, the Director has suggested exploring it by taking documents from other IITs and convening for it in the next meeting with MoE.
