The Chairman welcomed all board members and invitees and called the meeting in order. The secretary informed the board that Prof. Bharat Bhasker, director of the Indian Institute of Management, Ahmedabad, has requested a leave of absence. Joint Secretary (TE), MoE, had emailed her comments on the agenda items. The comments were placed, read out before the board & incorporated.

1. Announcement to be made by the Chairman.

At the outset, the Chairman welcomed all members in the meeting and announced that the Hon'ble President of India, Smt. Droupadi Murmu will be the Chief Guest at the 3rd and 4th Joint Convocation of IIT Bhilai on 26th Oct 2024. He congratulated the IIT Bhilai team for ensuring that the first convocation of the permanent campus is at the hands of the Hon'ble President of India. He also congratulated IIT Bhilai for securing the 73rd rank in NIRF 2024 in the Engineering category, an improvement from the 2023 rank of 81st in 2023. He also mentioned that Niti Aayog, in its Phase B report of 3G IITs, has highly appreciated IIT Bhilai for improving its ranking by eight places. Then, the Chairman called for the meeting to start.

2. Confirmation of the minutes of the 21st BoG meeting of IIT Bhilai held on 3rd July 2024.

The Secretary BoG intimated that the minutes of the 21st meeting of BoG were circulated to the board members on 11th July 2024. No comments have been received on the minutes to date. The Chairman further invited comments on the floor, and in the absence of any further comments, the board passed the following resolution:

3. Review of the action taken on the resolutions of the 21st meeting of BoG of IIT Bhilai.

The board was apprised of the actions taken on the resolutions arising from the previous board meetings. The board passed the following resolution:

"The Board noted the actions taken on the resolutions of the 21st board meeting of IIT Bhilai held on 3rd July 2024."

4. Consideration and approval of the Annual Report 2023-24 and audited Annual Accounts 2023-24.

The final draft of the Annual Report 2023-24 and audited Annual Accounts 2023-24 was presented before the Board and was discussed at length.

In view of the above, the board passed the following resolution:

"The Board approved the Annual Report and audited Annual Accounts for the FY 2023-24."

5. Consideration and approval of the change of Hindi name of the Department of Liberal Arts.

The Board members were briefed on the faculty members of the Department of Liberal Arts recommended in a meeting held on 25 September 2024 that "शिष्टकला विभाग" the name of the department in Hindi in institute records does not convey the meaning and intellectual ethos of the term "Liberal Arts." Upon extensive deliberation, the department had request that an appropriate and approximate rendering of "Department of Liberal Arts" in Hindi will either be translated as "मानविकी और सामाजिक विज्ञान विभाग" or transliterated as

“लिबरल आर्ट्स विभाग”. The Board discussed the issue and asked whether other IITs and Liberal Arts Institutes were consulted regarding the Hindi name.

In view of the above, the board passed the following resolution:

“The Board requested the Department of Liberal Arts to take feedback from other IITs and Liberal Arts Institutes across the country for uniformity.”

6. Consideration and approval of the Centre for Culture, Language, and Traditions logo.

The BoG was apprised that the Centre for Culture, Language, and Traditions (CCLT) was established as approved by the Board of Governors, IIT Bhilai, in its 21st meeting on 3rd July 2024. A committee of the Centre was constituted, and the committee proposed adopting a logo to ensure seamless visibility within and outside the institute in its meeting on 30th September 2024. The logo was inspired by Bastar art and aimed to convey the ethos of Chhattisgarh’s heritage and IIT Bhilai’s role in supporting and promoting it.

In view of the above, the board passed the following resolution:

“The Board approved the logo of the Centre for Culture, Language, and Traditions.”

7. Consideration and approval of the online UG and PG degree Executive MTech as a new program in addition to eMasters for working and experienced candidates.

The Board was informed that when the eMasters program was launched, many potential applicants requested to change the program name to “Executive MTech” instead of e-Masters. Among the admitted students, 90% are working professionals from industry. For potential applicants and from an Industry perspective, the term “Executive MTech” seems to carry an overall attractiveness and perceived value more than “eMasters.” In addition, several

students withdrew their interest because the program's name is e-Masters. Other IITs are also running "Executive MTech" program.

In view of these concerns, the e-Education Cell is constituted to ensure the smooth functioning of online UG and PG programs. It is recommended that one more online PG degree programs may be started as "Executive MTech" along with "eMasters."

Further, it was informed to the Board that IIT Bhilai would generate revenue from the current first batch of eMasters of 97 students for two years duration. Executive MTech will enhance the program's marketability and industrial relevancy and attract a larger pool of high-quality applicants.

In view of the above, the board passed the following resolution:

"The Board approved the online PG degree program Executive MTech along with eMasters program and appreciated the efforts and contribution of the e-Education Cell. Further the board authorized the Director for courses of both PGs/UGs programs and MoUs."

8. Consideration and approval of the student's program completion.

A list of 07 students (03 students in BTech, 01 students in MTech, and 03 students in PhD) who completed their respective credit requirement for the award of degree as recommended in the 24th Meeting of the Senate held on June 28, 2024, were presented to the BoG members. The board passed the following resolution:

"The Board approved the above students' program completion."

9. Consideration and approval of the additional faculty positions in the institute.

In line with the DPR of IIT Bhilai's projection, the board had approved 106 faculty positions to be created for Phase A of the construction. A total of 77

faculty members have joined, and the process for recruitment of another bunch of approx. 20 faculty members are in line. Approx 1300 students have been admitted in various courses/ programs, and accordingly, the additional requirements of faculty members were envisaged. Thus, it was proposed that a further 31 faculty positions be approved, which aligns with the DPR. The Ministry of Education commented that the Institute should wait for Phase B approval of the DPR for 3G IITs and that sanction for both faculty and non-teaching staff would come together.

In view of the above, the board passed the following resolution:

"As per the comments from the Ministry, the Board requested IIT Bhilai to take up early approval of Phase B of 3G IITs with the Ministry of Education."

10. Consideration and approval of the adoption of the common panel of visitor nominees on the selection committee for selection of professors in IITs sent by the MoE.

The Board was apprised that as per the MoE letter no. F.No. 24-4/2018-TS.1, Dated 20th September 2024, has sent a letter to the Directors of all IITs regarding the appointment of a common panel of 254 experts as visitor nominees on the selection committee for the selection of professors.

Accordingly, it was proposed that the above-referred letter be adopted to append the list of experts in various groups for selecting professors. Apart from the already approved board nominee list, the same list was also proposed for selecting Assistant/ Associate professors.

In view of the above, the board passed the following resolution:

"The Board approved the common panel of visitor's nominees for the selection committees for Professors and may also for Associate and Assistant Professors as expert members as given in the MoE letter dated 20 Sep 2024."

faculty cadre in IITs, the reservation roster of faculty cadre in IIT Bhilai was prepared. The reservation roster was applied to the posts filled through Mission Mode Recruitment after the implementation of the CEI (Reservation in Teacher Cadre) Act, 2019, and the posts filled before the implementation of Mission Mode Recruitment were categorized as Legacy Register.
