### 1. To confirm the minutes of the 17th FC meeting of IIT Bhilai held on 13th March 2024.

The minutes of the 17th FC meeting were circulated to the Finance Committee members on 26th March 2024. No comments were received on the minutes to date. The Chairman further invited comments on the floor, and in the absence of any comments, the minutes of the 17<sup>th</sup> Finance Committee meeting were confirmed as such.

### 2. To note the action taken report on the resolutions of the 17th meeting of FC.

The Committee was apprised that there was no item for reporting in the 17<sup>th</sup> meeting of FC. The FC passed the following resolution:

#### 3. To consider and approve the Annual Accounts for the FY 2023-24.

The Annual Accounts for the FY 2023–24 were presented to the board, and it was informed that accounts are prepared in line with the guidelines of the common format of accounts by MoE and have been vetted by the internal auditor M/s Borkar and Majumdar Associates. Subsequently, the CAG team commenced the audit of accounts on Dt. 24 Jun 2024.

The chairman appreciated the efforts and emphasized keeping an eye on operating expenses as there was a considerable increase after shifting to the permanent campus.

The Finance Committee passed the following resolution:

"The Finance Committee recommends the Annual Accounts for the FY 2023-24 to the board for its approval."

### 4. To consider and approve Signing of the MoU with the MoE to receive grants for the FY 2024-25.

The Institute must sign an MoU with the MoE every year to receive grants. This year's format for the MoU is yet to be obtained from the MoE. It was proposed that the Director be authorized to sign the MoU as per the prescribed format of the MoE.

The Finance Committee passed the following resolution:

### 5. To consider the adoption of the latest changes in the GFR

The Ministry of Education, vide letter No. 7-13/2018-TS-1-Part (2) dated 4th June 2024, recently circulated amendments in GFR by the Dept of Expenditure for ease of procurement through the GeM portal letter no F. 20 / 42 /2021 – PPD dated 20.05.2024 (Annexure 3).

It is proposed to adopt the changes made in our procurement policy as follows:

The amended rules will be followed in the procurement procedure as follows:

- i. Rule 133 (3) regarding repair works Amended GFR will be followed up to 31.03.2025.
- ii. Rule 154 regarding Purchase of goods without quotation In IIT Bhilai as per the amended GFR, up to the value of Rs 50,000/— will be made as per the delegated powers and between Rs 50,000/— to Rs 1,00,000/— with the approval of the Director only. These powers will be used when the required goods are unavailable on GeM, as given in the amended GFR. The certificate in the amended GFR would be mandatory for all bills.
- iii. Rule 155 regarding Purchase of goods by Purchase Committee Amended GFR up to Rs 500,000/– will be made per the IPC rules and between Rs 500,000/– to Rs 10,00,000/– with the approval of the Director only. These powers will be used when the required goods are unavailable on GeM, as given in the amended GFR. The certificate in the amended GFR would be mandatory for all bills.

The Finance Committee passed the following resolution:

"Committee recommends adopting the recent changes in GFR for the board's approval."

6. To apprise about the requirement of additional funds under OH 31 (General) from the MoE.

This year, IIT Bhilai received a sanction of Rs. 22.07 Cr from MoE for OH 31 (operating expenses head). However, the operating expenditures after entering the new campus have increased multifold. Accordingly, a request to increase allocation under OH 31 head from 22.07 Crore to 39.23 Cr. has been sent to the MoE.

The committee deliberated on the item-wise components of expenditure and agreed on the estimates proposed to the MoE.
