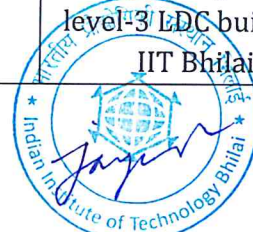

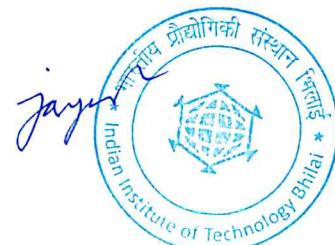

1. Announcement made by the Chairman.

At the outset, the Chairman welcomed all members present in the meeting and made the following announcements:

- IIT Bhilai was dedicated to the nation on 20 Feb 2024 by the Honourable PM Shri Narendra Modi virtually from Jammu. He was privileged to be on campus with the CM of the State of Chhattisgarh, Shri Vishnu Deo Sai, who graciously participated in the dedication ceremony. He thanked all the BoG members, IIT Bhilai team members, CPWD, L&T, Architects, Students, and the hundreds of workers because of whom the campus is now fully functional.
- The Pan IIT USA held the IIT 2024 Global Conference in Washington DC, and Director, IIT Bhilai participated.
- IIT Bhilai students participated in the Inter IIT Sports meet 2023 in Gandhinagar and did creditably well.
- Students of Goa visited IIT Bhilai as a part of the Yuva Sangam Phase III. Yuva Sangam program aimed to provide multi-dimensional exposure under five broad areas, which are: Paryatan (Tourism), Parampara (Traditions), Pragati (Development), Paraspar Sampark (People-to-people connect), and Prodyogiki (Technology).

- e. The Indo-German Science and Technology Centre (IGSTC), TU Berlin, and IIT Bhilai held a workshop on “Recent Advances on Harnessing Green Hydrogen and Allied Areas” on Nov 23.
 - f. IIT Bhilai and Universität Siegen held an Indo-German workshop on Integration of Sensors with AI Hardware on Feb 24. Also, the efforts of the Director for joint degree programs with Penn State University USA and Cologne University Germany.
 - g. There was also a Slovenia Pre-conference School on Algorithms, an international conference on Algorithms and discrete applied mathematics (CALDAM), and a 2-day international conference by the Liberal Arts Department along with the Association for Literary Urban Studies, Helsinki.
 - h. NTPC signed an MoU with IIT Bhilai to set up a 500 kWp solar panel facility under the RESCO model on 27 Feb 2024.
 - i. Some of the creditable achievements of students were:
 - (a) Ms. Jyoti Rani, PhD student of Math, won the Chhattisgarh Young Scientist Award 2024.
 - (b) Ms. Thandar Zaw, a Ph.D. student in physics, won the Oral Presentation Award at GLA University Mathura.
 - (c) Mrs. Subhalaxmi Nayak, a Ph.D. student in physics, won the best poster award at the University of Allahabad.

The board suggested the amendment in statute clause 12 (xv) on Page 889 as follows:

*"In the event of the occurrence of any vacancy in the office of the Chairman of Board of Governors by reason of expiry of tenure, death, resignation or otherwise or in the event of the Chairman being unable to discharge his functions owing to absence, illness or any other cause, **one of the Chairmen of any other IITs** (i.e. in place of Institutes of National Importance (INIs)) **and Director as co-chair**, as nominated by the Visitor, may discharge any or all the functions assigned to the Chairman under Statute 12 (XV) for a period of six months or appointment of regular Chairman, whichever is earlier. In case of expiry of tenure, the Visitor may extend the term of the incumbent Chairman for a period of six months or till appointment of regular chairman, whichever is earlier."*

5. Consideration and approval of the revision in policy for inclusion of new teaching and non-teaching staff joining IIT Bhilai for HRA.

The board was apprised of the representations received from new teaching and non-teaching staff requesting to add the criteria for the newly joined and existing teaching/non-teaching staff to avail permission for HRA.

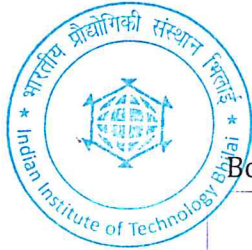
