6. The material should be supplied and installed within 15 days from the date of purchase order.
7. Your quotation must be valid for a minimum of 90 days from the date of opening of tender.
8. The material should be of good quality and brand.
9. GST Number should be clearly mentioned in your offer, failing which your offer may not be considered.
10. **Advance payment is not admissible. Payment shall normally be made within 30 days subject to receipt and acceptance (as per Work Order Terms) of the ordered materials/services.**
