4. Bidder Should be authorised dealer of the reputed brand of required setup. (World Athletics approved certificate required).
5. Bidder should quote the price of all product and all should be of reputed brand.
6. Prices should be in Indian Rupees and should be inclusive of all Taxes, Duties & FOR IIT-Bhilai.
7. The material should be supplied and installed within 30 days from the date of purchase order.
8. The supply shall be required to start and complete as per the instructions of IIT-Bhilai.
9. Your quotation must be valid for a minimum of 90 days from the date of opening of tender.
10. The material should be of good quality and brand.
11. GST Number should be clearly mentioned in your offer, failing which your offer may not be considered.
12. **Advance payment is not admissible. Payment shall normally be made within 30 days subject to receipt and acceptance (as per Work Order Terms) of the ordered materials/services.**
