- 1) Bidders should fulfil and comply with the given specifications (Technical Compliance should be submitted as a technical bid).
- 2) **All bidders should quote Prices in Indian Rupees and should be inclusive of all Taxes, Duties & Price should be quoted FOR IIT Bhilai.**
- 3) All quotations will be evaluated for selecting the L1 price (i.e. Grand Total wise) and the L1 Bidder will be awarded the Purchase Order. The item shall be required to be delivered in the CIF Department through the Stores and Purchase Section of IIT Bhilai at the risk and cost of the bidder, if applicable.
- 4) Your bid must be valid for a minimum of 90 days from the date of opening of the tender.
- 5) The items are required to be delivered and installed **within 6 - 8 weeks** from the date of the purchase order, late delivery may not be accepted.
- 6) **The quotation should be submitted through the e-procurement portal only.**
- 7) Attested copy of the GST Certificate is to be attached to the bid.
- 8) The items offered should be of good quality.

- 9) Advance payment is not admissible. Payment shall normally be made within 30 days subject to receipt and acceptance (as per Purchase Order Terms) of the ordered materials/items. Part delivery to be accepted and Part payment may be made upon the part delivery.
- 10) In case of the unscheduled holiday in Durg being declared on the prescribed closing/ opening day, the next working day will be treated as the scheduled prescribed day of closing/ opening of the tender.
- 11) Institute reserves the right to accept the delivery in part of supply or full of supply.
- 12) Liquidated Damage: IIT Bhilai reserves the right to levy a penalty of 0.5 % of the order value per week or part of the week of delay in supply and /or installation, beyond the schedule as mentioned in this tender document, subject to a maximum of 10% of the order value. IITBH reserves the right to cancel the order if the delay is more than 06 weeks. The delay in delivery and/or installation not attributed to the supplier, viz. delay in site preparation, delay in submission of required documents, etc. and the conditions arising out of Force Majeure will not be considered for the purpose of calculating penalties.
- 13) Any other information that you may like to obtain, you are free to contact IIT Bhilai through mail at sp@iitbhilai.ac.in before submitting the quotation.
- 14) IIT Bhilai reserves the right to reject any or all bids, amend/ withdraw any terms and conditions in the document or cancel the NIQ at any stage without assigning any reason.
- 15) Pre-eligibility criteria:-**
- a) The bidder must be an OEM or authorised dealer of the sputter target. OEM Certification or Authorization letter must be submitted along with the bid.
- b) The bidder/OEM must have supplied similar sputter targets to at least two centrally funded Technical Institutions/CSIR labs/Government organizations in the past 5 years. Documentary evidence (i.e., a PO copy) in support of the same must be provided along with the bid.
- 16) **Terms and Conditions:** - Bidders must agree to provide certificates confirming purity of each of the targets. The certificates must be issued by a standard and reputed certification agency at national or international level, for example, NABL India. IIT Bhilai has the right to reject certificates if not issued by some standard agency. Agreement of the bidders to provide certificates confirming purity shall be made in official letterhead.
